

Field Trip Permission Form



I am the parent/legal guardian of _____. I consent to this minor child leaving Gallery 37 Center for the Arts on Thursday, April 21, 2016 at about 9:30am to be transferred by an independent bus company contracted by After School Matters on a College Tour as a part of ASM U, an After School Matters program. I will be notified of the specific location of the College Tour by email on the first day of the ASMU program.

I understand that my child will return to Gallery 37 Center for the Arts at about 1:15pm on the same day. I consent to my child participating in various activities as part of this field trip including bus transportation and the College Tour. I understand that there is a risk of my child sustaining injury.

I understand that there is a risk my child will sustain injury or become ill during the College Tour. In the event that my child's emergency contact cannot be reached in an emergency, I give permission to a physician selected by After School Matters to secure proper treatment for my child in case of an illness or injury. I authorize the use or disclosure of my and my child's health information for purposes of securing health treatment. I agree that I may be required to pay all or most of the expenses incurred for such treatment.

I release and hold harmless After School Matters and its employees from all liability for any injury or illness my child may sustain, including the aggravation of any prior existing injuries, except where such injury or illness was caused by the willful misconduct or negligence of After School Matters. I fully assume all responsibility for injuries or illnesses my child may sustain while traveling to or from the program or while participating in program activities, except where such injury or illness was caused by the willful misconduct or negligence of After School Matters.

I agree that After School Matters is not responsible for lost, stolen, or damaged property, including articles of clothing. This Program Acknowledgement, Consent, and Release shall inure to the benefit of the legal representatives, licensees, and assigns of After School Matters, and shall be binding upon me and my heirs, legal representatives, and assigns.
